

**Overstayers' Fees – Accepted programme offer in 2023**

Students who have exceeded the normal programme duration (less the number of semesters of Tuition Grant previously received), are no longer be eligible for the Tuition Grant and GST subsidy from MOE. They will pay non-subsidized fees (ie. full fees) as summarized in the following table.
